House of Delegates Report

Dear Board of Directors,

I want to express my sincere gratitude for your support in my attendance at the 34th Annual House of Delegates Meeting and Conference. As always, it is an amazing experience to be among colleagues and my learning is continual. I wanted to report some of the highlights from this years meeting.

San Francisco is an amazing city with many different cultures. The conference celebrated Chinese tradition and beautiful dancers and a dragon entertained us at the Opening Session. Everyone received a special PA fortune cookie. Guest speaker and nationally recognized photographer, Steve Uzell, delivered his message about seeking new perspectives beautifully choreographed with his exceptional portfolio.

As you know, the focus for PA's this year has been Healthcare Disparities. Many awards were given to outstanding PA's and MD's for their efforts. Our President Elect Mary Ettari has selected Patient Safety with

attention to reduction of medical errors as the charge for this year.

The House had their sessions over three days. With 180+ delegates and more than 60 alternates, a quorum was met. General election results were discussed. More than 27,000 ballots were sent to members and over 4000 returned. Bruce Fichlander gave his always popular Treasurer's report. The Academy has experienced its 19th consecutive year of running a budget excess, this year some \$1.6 million dollars. He reported a growth in membership of 4.1%. The AAPA has ~29,000 members, about half of the PA population. There are ~ 5.700 student members. State chapter awards were given to Alaska, Minnesota, Michigan, and North Carolina.

President Rick Rohrs gave an address by special request to discuss the recent information concerning specialty credentialing by businesses other than the NCCPA. The NCCPA has stated it intends to remain the credentialing body for the AAPA.

PRECEPTING - Try It, You'll Like It

We've all heard the saying "see one, do one, teach one" but how often do we get to carry through on that once we are out in a busy practice setting? If you recall the best learning experiences you had in training, or early practice, you do so with some degree of gratitude.

Those people who took the time, who had the most sharing enthusiasm, and who passed on needed lessons with respect for us, (and maybe some humor!), are not easily forgotten.

We remember well, not only the lessons, but those individuals who impressed us the most with their integrity, compassion for patients, work ethic, and willingness to ask questions themselves.

What you may not know is how much they gained themselves. You may not have seen their own satisfaction in lessons learned, pride in your progress, and how gratifying it is to return the favor - as all teachers were once students.

From the Medical Board From Reza Ghadimi PA

The medical board met last May and passed two issues that were of interest to PAs. Upon expiration of a PA license, PAs now have up to 90 days to renew their license. Should you be careless enough to allow your license to expire, you will have to pay a late fee but will not loose your license.

The board also passed a new rule to allow PAs, who take the NCCPA test, a one year grace period to retake this test in case of failure. The PA's license will not be affected and he or she can continue to work while preparing to retake the test.

PAs in New Mexico have a good track record. Because of our suc-

cess, many other healthcare providers who are asking for similar privileges, compare themselves to PAs. We need to be mindful of this issue. Though they have a right to request those privileges, their comparison to PAs is unfounded. There is a fundamental difference between us that must be kept in mind when any comparison is made. PAs work under the direct supervision of physicians and under the medical boards rules. No PA to date works independently in New Mexico. The healthcare providers who are seeking privileges similar to ours, work independently and under their own board regulations. The medical board or the osteopathic board has no

jurisdiction over them. This makes the comparison inapplicable.

House of Delegates Report

A special task force has been established to examine the needs for specialty training. AAPA representatives will be on this task force to ensure our policies are considered. Pathways II is being phased out as an option for recertification.

The House decided some 65 resolutions and 5 policies set for expiration, deemed outdated, unclear, or incomplete. Three Reference Committees (A, B, and C) worked to make recommendations to the House on a variety of resolutions. We considered having the AAPA collect State dues, but with strong opposition (for a variety of logistical reasons) from CEO Steve Crane, we rejected the resolution. We will do a feasibility study for a public awareness campaign to promote the Physician-PA team model. The House has denied a voting membership to the Assoc. of Postgraduate PA Programs (APPAP). The Academy has no reciprocal representation within the APPAP organization. After significant debate, the position paper entitled "Guidelines for Ethical Conduct for the Physician Assistant Profession" was amended. Changes were made in areas of ethical obligation for patient

care, use of computerized data storage and transmission, patient referral, and complimentary and alternative medicine. Students now have a onetime AAPA dues fee of \$75, covering them for as long as they are enrolled in their program. The AAPA encourages higher education institutions to recognize the Master's degree as the terminal degree for tenure. We also now have a formal position in opposition of actions by pharmacists that limit access to care, such as refusing to fill prescriptions based on personal or religious beliefs. We support State Regulators doing criminal background checks for licensure of PA's. Anyone considering DMAT should read the position paper "The Physician Assistant in Disaster Response: Core Guidelines," to gain an understanding of broad requirements and preparation.

There were also several discussions concerning degree status of PA's. We considered a few resolutions that touched the edge of this controversial subject. Most all of us agree that we see a trend in higher and higher degrees that seems to be driven by an unseen force. In rough figures,

the PAEA believes over 65% of PA's hold a Masters and about 14% a PhD. This issue makes me think of a line in Tuesdays with Morrie when he describes a "tension of opposites, like a pull on a rubber band, and most of us live somewhere in the middle." We can not forget the history of PA's nor bury our heads against the future. I predict this will be a topic that we will attempt to address and sincerely hope it will not be divisive to our brotherhood.

I am always available to discuss details of the HOD sessions or provide copies of any adopted resolution of interest. Our policy manual is a work in progress. I have suggested we use some of our newsletter space to develop a column about current PA policy. I absolutely have enjoyed my experiences with HOD work and I am so appreciative of the Academy's support of my time there in representing New Mexico.


