## From the Medical Board -

New Mexico has become a hot spot for PA jobs. Over the past few years, many physicians in primary care have either retired or moved to other specialties. This has left a void in this very important area of medicine. In recent annual meetings of the national organizations of internal medicine and family practice groups, a major aspect of concern was the shortage of primary care providers nationwide. Understandably, this task have been given to PAs and NPs. This is true in New Mexico as well as nationwide.

Those of you who attended the New Mexico Primary Care Update last September heard first hand the concerns of some our fellow PAs. The exodus of primary care doctors from the rural areas is of special concern. Doctor Alfredo Vigil who manages the Health Centers of Northern New Mexico and hires many PAs gave a very awakening lecture on the importance of PAs and their role in primary care medicine in New Mexico. Since a majority of PAs as well as NPs and doctors now work for organized medicine, our rules need to address the expectations of these organizations. I have been working both at the Board level and the legislative level to address these issues. I am happy to inform you that

we have been successful in making many of the necessary changes for our New Mexico PAs. However our job is not done and I need your input and help. I need to know of any particular problems you may be facing at your work place. Many of us have been putting up with aggravating and annoying problems for many years, only to find out that we didn't need to. Chances are that what is bothering you is not unique and troubles others as well. The Board can not help you if we don't know your problem.

One area of concern that was brought to our attention has been the format of our licenses. Up to this point, licenses issued to PAs in New Mexico shows the name of the PA and his or her supervising physician. Since many of us work at several job sites, often in a different office from that of our supervising physician, our license has created confusion and questions regarding supervision. We have discussed this at the Board and it seems that there is no real rule to have the name of our supervising physician on our license. It has just been a tradition. To keep with the times and eliminate this confusion. the Board will do away with this practice. So in the near future, when you apply for a New Mexico license

or renew your existing license, it will only show you as the licensee. The name of your supervising physician will not be printed on your license. Of course you still need to have a supervising physician and the Board needs to know who that supervising physician is BEFORE you start work. Also all other rules still apply. For example if you change jobs or supervising physicians, you need to notify the Board.

Please let me know if there are any issues at your work place or if you are facing any particular problems. All information will be kept confidential and we will try to resolve it for you.

## PREVENTIVE HEALTH SERVICES AT WORK

When Wabanang Kuczek, MPH, PA-C, started working at the College of Santa Fe in August 2004, she realized that a large percentage of students were smoking cigarettes. Wabanang explained: "It seemed that students who did not smoke were more the exception rather than the norm. Some research confirmed my belief that if this was the situation at CSF, then college students in general represent a large portion of the smoking public and therefore contribute to the serious health problem related to smoking cigarettes in today's society".

As a Physician Assistant, Wabanang takes any opportunity to educate her patients about the importance of preventive medicine. At the college of Santa Fe, she believed that it was her responsibility not only to take care of present medical problems, but also to encourage students to develop healthy lifestyles. These improvements will also aid in their achieving successful careers. At CSF, when she was asked to be part of a wellness committee, she saw a unique opportunity to develop a college smoking cessation program. Wabanang developed a curriculum and put together materials for teaching a smoking cessation course for credit at CSF. In addition, she started a similar and individualized program through the Student Health Services for students who could not take the class due to time conflicts.

Although quitting smoking is a very difficult undertaking, the credit course and the clinic program have been powerful motivators and have aided students in their quitting efforts. This year, during a "Freedom from Smoke Ceremony", nine students received certificates

for successfully quitting either after passing the credit course or completing the clinic program. The students were genuinely happy to receive their certificates and some said that they were sending the certificate to either parents or loved ones to show they have quit smoking

The credit course sessions cover training about the health effects of smoking via lectures and videos, nicotine replacement therapy, and individual and group counseling. Wabanang has found a correlation between the amount of counseling and the effectiveness in quitting. Students who receive sessions on health education and motivational counseling appear to have an easier time in the quitting process. The process of motivational counseling uses empathy rather than confrontation and it acknowledges that the student, not the provider, is responsible for changing behavior. In addition, she brought in students from previous classes who are now non-smokers, to provide motivational support. It appears that students who are successful in quitting welcome the opportunity to become mentors themselves, and find it rewarding coming back and talking to other students who are attempting to quit.

Likewise, the program through the Student Health Clinic, offered many of the same materials and counseling offered through the credit course. In sum, students have reported that the convenience, flexibility and affordability are important for them in their decision to start the smoking cessation program at CSF.

Wabanang also worked on a nutrition/weight reduction program

for the students and staff at CSF. She took time outside clinic hours to exercise with students and staff. "It is truly rewarding to see positive results of any endeavor when you know you are helping someone change their lifestyle for the better" Wabanang said. During her career of more than twenty years as a medical provider, she has been involved with different groups and in different preventive medicine programs. Wabanang is an avid long distance runner, and this past summer was awarded several medals for finishes in her age category in competitive races.

We congratulate Wabanang for the development and implementation of preventive health programs in an effort to make a difference in the life of her patients.

# RECHARTERING in FUTURE

As recently described in the AAPA News, all chapters must re-charter every five years. This is according to AAPA House of Delegates policy HA-2300.3.4. This requires providing information on the organization, bylaws and incorporation status.

The New Mexico Academy of Physician Assistants will be due to re-charter in 2009. It is never too early to start preparing for that process, particularly as it will be an opportunity to review bylaws and confirm that our basic chapter requirements are current.
